**AGREEMENTS OF CONSTESTANT(S)**

**As to any Fisherman’s Choice LLC., Tournament entered in or participated in by the undersigned, the undersigned does hereby agree as follows:**

- 1. Assumption of Risk.** I understand and realize all of the risks and hazards involved any time I fish any tournament and operate a boat on a lake. I hereby assume all risks associated with my participation in any fishing tournament, including all injuries or damages I may suffer to my person or property involved in my participation.
- 2. Sponsor(s) Default.** I hereby release Fisherman’s Choice LLC. and its’ managers, members, agents and employees from any and all damages, claims, demands, costs or expenses caused by sponsor(s) default of agreements.
- 3. Liability Release.** I hereby release Fisherman’s Choice LLC., its’ managers, members, agents, employees and sponsors from any and all damages, claims, demands, costs or expenses relating to injury of any person(s) or damage to any property which I may cause by reason of my participating in, or which arise in connection with, any Fisherman’s Choice LLC. Tournament participated in by me.
- 4. Covenant Not to Sue and Waiver of Subrogation.** I further agree that I will never sue Fisherman’s Choice LLC., for damages on account of any injury or damages I suffer or cause, whether known now or which may develop in the future, in connection with any Fisherman’s Choice LLC., Tournament. In the event that Fisherman’s Choice LLC. is sued because of my actions, I expressly agree to indemnify and hold Fisherman’s Choice LLC., harmless from any and all liability whatsoever including court costs and attorney’s fees arising with respect to such actions.
